

Privacy Statement of the Company

The Company ("SHARE") recognizes that our clients entrust important personal data (such as, but not limited to, data that can be used to identify an individual) and we wish to assure our customers that protecting and safeguarding sensitive data or information is our utmost priority.

SHARE will only use those personal data in accordance with the purposes set forth in this privacy statement and is committed to safeguarding the personal information collected.

A. Use of Information & the Customer data

- 1. We shall safeguard confidentially of our customer data in accordance with stringent security standards.
- 2. We will limit the collection and use of customer information to the minimum required to deliver services to our customers, which includes advising our customers about our products, services and other opportunities.

The Company hereby disclaims any liability arising from the use of such disclosure of information to any external organization.
- 5. Our outside vendors are required to adhere to our privacy statement, the policies and the respective standards of compliance while providing the support services to us as agreed and shall allow us to audit such compliance accordingly.
- 6. For the purpose of credit reporting we will exchange the information about of customers with the reputable reference sources and clearing house services.
- 7. We will not use or share internally or externally the personally identifiable medical information for any purpose other than underwriting or administration of a customer's policy, claim or account, or as disclosed to the customer when the information is collected, or to which the customer consents.

- 8. We will attempt to keep customer files complete. Up to date and accurate. We will inform customers how and where to conveniently access their account information (except when we are prohibited by law), and how to notify us about errors which we will promptly correct.
- 9. We will continuously assess ourselves to ensure that customer privacy is respected.

B. Internet & Website Privacy

- 1. Personally identifiable information ("Information") means information that is collected by the company ("we" or "us") and how it may later be disclosed.
- 2. The Company endeavors to safeguard and ensure the security of the information provided by the customer. When the information provided by the customers is not transmitted through this encryption. The customer's system (if configured accordingly) will display an appropriate message ensuring the best level of secrecy for the customer's information.
- 3. Communication using the internet is strictly within our system only. In order to maintain the security of our systems, protect our staff record transactions, and, in certain circumstances, to prevent and detect crime or unauthorized activities, the Company reserves the right to monitor all internet communications including web and email traffic into and out of its domain.
- 4. The company classifies certain information as sensitive and does not seek to collect sensitive personal data (such as data reveals political opinions, religious beliefs, or data concerning health or sex life) through this site or in any manner of communication. If the company does seek to collect such data, your prior consent hereto will be asked. Please note that, by providing SHARE with unsolicited sensitive personal data you consent to us using those data are described above.
- 5. Please note that this Privacy statement does not extend to third party sites linked to this website.
- 6. Data provided by the customer is retained as long as the purposes for which the data was collected continues, once the customer closes the account /, customer information should be retained only for limited time period and then discarded. The data is then destroyed unless its retention is required to satisfy legal, regulatory or accounting requirements or to protect the interests of the Company (SHARE).

7. Use of Cookies

SHARE may gather and analyze the information regarding the usage of this website, including domain name, the number of hits, the pages visited, previous / subsequent sites visited and length of user session. This information may be gathered by using a cookie. A cookie is a small piece of information that a website stores on customer's computer hard drive that can later be retrieved and read only by the same site.
